### CORONAVIRUS DISEASE (COVID-19) ADVISORY AND MEETING PROCEDURE

On March 16, 2020, the Health Officer of Contra Costa County issued an Order through April 7, 2020 that directed that all individuals living in the county to shelter at their place of residence except that they may leave to provide or receive certain essential services or engage in certain essential activities and work for essential businesses and governmental services.

The seven Bay Area Public Health Officers who ordered a shelter in place in mid-March will extend the orders through May 31. This new Order replaces the shelter order issued on March 31, 2020. The March 31 order is the "Prior Order" and the April 29 Order as the "new Order" or "Order." This new Order will go into effect on 11:59 pm on Sunday May 3, 2020, and will remain in effect until 11:59 pm on Sunday May 31, 2020, unless the Health Officer amends or extends it.

Under the Governor's Executive Order N-29-20, this meeting may utilize teleconferencing, as a precaution to protect the health and safety of staff, officials, and the general public. SWAT members will not be physically in attendance, but will be available via video conference.

There will be no physical location for members of the public to participate in the meeting. We encourage members of the public to shelter in place and access the meeting online using the web-video communication application, Zoom. Zoom participants will have the opportunity to speak during the Public Comment period (for topics not on the agenda), in addition to each of the agendized items.

### **6.A** Receive update – I-680 Contra Costa Express Lane

Barbara Laurenson, Metropolitan Transportation Commission presented item. Ms. Laurenson provided updates:

- Northern 680 Express Lanes (southbound extension from Martinez to Alamo will initiate toll collection August 20, 2021.
- Revised Toll Zones
  - o Rules are the same as the I-680 Express Lanes:
    - Fastrak required
    - Free: 2+, Motorcycle, Buses
    - Half toll: Solo CAV
    - Full toll: Other SOV
    - 5 am 8pm

### **6.B** Receive update – Contra Costa Countywide Vision Zero Framework

Colin Clarke, CCTA presented item and articulated that the update will focus on:

- Clarification of the purpose and intent of collision corridor map;
- Prioritization of Projects and Funding for Local Agencies; and
- Enhancement of the common collision corridor map to show additional details.

Mr. Clarke stated that the collision data collected represents January 1, 2008 to December 31, 2017. The source is from the Statewide Integrated Traffic Records System accessed using UC Berkeley SafeTREC's Transportation Injury Mapping System. And, the data excluded Highway collisions, and Property damage only (PDO) collisions.

Mr. Clarke presented maps depicting info such as:

- Pedestrian Priority Areas (PPAs)
- Common Patterns: Collisions Involving Bicycling & Walking
- Countywide Common Corridors
  - o Collisions While Walking and Bicycling

Terence Zhao from Fehr & Peers shared interactive maps for both South County and Countywide Common Collision Corridors for Walking and Biking.

Mr. Clarke stated that the future Measure J transportation funding would not be solely dependent on Countywide Vision Zero data from 2008 through 2017.

Renata Sos requested clarification on a sentence in the staff report. And, asked if the sentence means the projects in those corridors highlighted on the maps are to be prioritized?

The project funding is not anticipated to be limited to only the corridors on the maps.

Mr. Clarke replied that it depends on the funding source as each funding source has different criteria, but in terms of what is anticipated for Measure J funding, it is not anticipated that funding would only be allocated to corridors called out in the Vision Zero plan/maps.

Ms. Sos also asked for clarification on the following sentence in the staff report.

If local agencies identify their priority projects within their jurisdictions, e.g., using authentic engagement per the Guide, those projects can be considered for Measure J funding.

Mr. Clarke clarified what using authentic engagement per the Guide mean, there is a section of the Vision Zero Transportation Safety Policy and Implementation Guide that includes the guidance on authentic engagement, it generally includes ideas from the different communities, so there is more equitable representation in terms of who is participating Countywide.

Amy Worth requested to view the interactive maps. And, asked if there are any plans to update the maps with recent data?

Mr. Clarke stated that recent effort kicked off in 2019.

John Hoang, CCTA, stated the information presented is one way to depict the data collected and that questions related to funding is premature, as CCTA has not created a funding mechanism for a potential new sales tax measure.

Matt Kelly, CCTA presented item. Mr. Kelly provided updates:

Expand Multimodal Transportation Service Objectives (MTSOs) to become Regional Transportation Objectives (RTOs) which consider:

- o Roadways
- o Transit
- o Pedestrian/Bike Network
- Climate Change added non modal
- o Safety added non modal
- o Equity added non modal
- Apply consistent structure and topics across all five Action Plans

### **Scope Review**

- Task 1: Scope Refinement and Data Collection
  - o Meet with RTPC's to discuss the draft scope and potential refinements

- Prepare final scope for each Action Plan
- Task 2: Data Collection and Baseline Modeling
  - Collect data related to land use, demographics, transportation system, travel demand, GHG emissions, collisions, equity, MTSO status, location project lists and costs estimates
    - MTSO will be renamed to RTO (performance measures)
  - Clean up land use data received from each jurisdiction
  - Conduct baseline roadway modeling
  - Summarize data collected
- Task 3: Assessment of Existing Action Plan and Identification of Potential Changes
  - Analyze existing vision, goals, actions, projects, MTSOs/RTOs, and Regional Routes for success and ongoing relevance
  - o Identify candidates for designation as new Regional Routes
  - o Meeting with the RTPC TAC to solicit recommendations for changes
- Task 4: Identification of New and Refined RTOs and Actions
  - Host stakeholder workshop
  - o Recommend potential retained, new and/or modified RTOs and actions
  - o Develop an updated list of projects, programs, and actions
  - Present at RTPC Policy Board

**6.D Approve Appointment** – Contra Costa County Accessible Transportation Strategic Plan (ATSP) Task Force

Lisa Bobadilla, SWAT Administrative staff presented the item. SWAT TAC is seeking a recommendation from SWAT to appoint one SWAT member to the Contra Costa Accessible Transportation Strategic Plan (ATSP) Task Force. On March 17, 2021, the Contra Costa Transportation Authority Board adopted the ATSP and directed staff to begin implementing the recommendations and strategies identified in the ATSP; primarily the formation of a Task Force to carry out initial task in the plan.

Both Contra Costa County and Authority staff have been developing recommendations for ensuring a Task Force Roster that provides the following:

- Representation of stakeholders providing accessible transportation services.
- Adequate knowledge and skills in delivering the specified tasks.
- Representation for the diverse geographic and demographic needs of Contra Costa County.

It is anticipated that the appointments be completed by mid-September with a first Task Force meeting taking place late September or early October. Authority staff will meet with new members prior to the first meeting to brief them on the background and status of the ATSP.

SWAT TAC recommends SWAT select one SWAT Committee member to the Contra Costa ATSP Task Force.

### Amy Worth nominated Dave Hudson to represent SWAT.





Committees (RTPCs)

At its September 15, 2021 meeting, the Authority discussed the following items, which may be of interests to the Regional Transportation Planning Committees:

A. 2022 State Transportation Improvement Program (STIP)

Recommendation: Staff sought Authority Board approval to 1) program \$25 million for the I-680 Coordinated Adaptive Ramp Metering (CARM) project, \$972,000 for Planning, Programming and Monitoring (PPM), and conditional upon the Metropolitan Transportation Commission's approval of the requested STIP loan, \$15 million for the I-680 Northbound Express Lane — Phase 1 project; 2) adopt Resolution 21-38-P, which indicates local support for the two projects; and 3) retain \$25 million unprogrammed for a later amendment in the 2022 STIP if the Project Study Report for I-680 CARM does not get completed by the required deadline.

Action: The Authority Board approved to 1) program \$25 million for the I-680 CARM project, \$972,000 for PPM, and conditional upon the Metropolitan Transportation Commission's approval of the requested STIP loan, \$15 million for the I-680 Northbound Express Lane – Phase 1

project; 2) adopt Resolution 21-38-P, which indicates local support for the two projects; and 3) retain \$25 million unprogrammed for a later amendment in the 2022 STIP if the Project Study Report for I-680 CARM does not get completed by the required deadline.

### NOTICE PREPARATION OF A DRAFT ENVIRONMENTAL IMPACT REPORT FOR THE 2023-2031 HOUSING ELEMENT UPDATE

#### October 2021

#### Introduction

The purpose of an Environmental Impact Report (EIR) is to inform decision-makers and the general public of the environmental effects of the proposed project that an agency may implement or approve. The EIR process is intended to provide information sufficient to evaluate a project and its potential for significant impacts on the environment; to examine methods of reducing adverse impacts; and to consider alternatives to the project.

The EIR for the proposed project will be prepared and processed in accordance with the California Environmental Quality Act (CEQA) of 1970, as amended, and the requirements of the Town of Danville. In accordance with Sections 15120 et seq. of the CEQA Guidelines, the EIR will include the following:

- A summary of the project;
- A project description;
- A description of the existing environmental setting, probable environmental impacts, and mitigation measures; and
- Environmental consequences, including (a) any significant environmental effects which cannot be avoided if the project is implemented; (b) any significant irreversible and irretrievable commitments of resources; (c) the growth inducing impacts of the proposed project; and (d) cumulative impacts.

The EIR also will discuss a reasonable range of alternatives to the project that could reasonably attain most of the basic objectives of the project and would avoid or substantially lessen any of the significant environmental effects of the project (CEQA Guidelines Section 15126.6[a]).

### **Project Setting**

Incorporated in 1982, the Town of Danville (Town) is a small, residential community located in the San Ramon Valley in Contra Costa County. It is located just 30 miles east of San Francisco and comprises 18 square miles with a population of approximately 43,582. The Town of Danville is characterized by its pleasant semi-rural ambiance, presence of single and multiple family housing, proximity to employment centers in the Bay Area, and its scenic beauty.

The Town is bordered by the unincorporated town of Alamo and Blackhawk community to the north, the City of San Ramon and unincorporated Contra Costa to the south, Las Trampas Regional Wilderness Park to the west, and the Diablo Range to the east. Major roadway access to the Town is provided by Interstate 680.

### Project Overview and Background

The Housing Element is a State-mandated policy document that is a component of the Danville General Plan. The Town of Danville adopted its current General Plan (Danville 2030 General Plan) in March 2013. The Housing Element must make adequate provision for the existing and projected housing needs of all economic segments of the community. The Housing Element establishes goals, quantified objectives, and policies, accompanied with a detailed work plan (i.e., implementation strategies).

The Town's current Housing Element (2014-2022 Housing Element) was adopted by the Town Council in April 2015 and certified by the State Department of Housing and Community Development (HCD). The adopted Housing Element covers the planning period from 2014 to 2022. Staff is currently implementing the respective actions and programs for the current planning cycle. The next housing cycle (6th Cycle) will cover the planning period from 2023 to 2031.

To comply with State law, the Town's Housing Element must be updated to ensure the Town's policies and programs can accommodate estimated housing growth need identified in the Bay Area Association of Government's (ABAG) Regional Housing Needs Assessment (RHNA) allocation for the 2023-2031 planning periods.

### 2023-2031 Housing Element Update Components

The 2023-2031 Housing Element Update will consist of five main components:

- 1. Assessment of Town-wide Housing Needs and Opportunities;
- 2. Drafting Goals, Policies, Programs, and Objectives
- 3. Preparation of CEQA Environmental Review documents
- 4. Preparation of the 2023-2031 Housing Element;
- Coordination with HCD to Obtain State Certifications

Completion of these five components and local adoption process are envisioned to take place from October 2021 through January, 2023, and will include opportunities to provide direction

regarding the content of the Housing Element, including information workshops and events, online community surveys and, and public hearings before the Planning Commission and Town Council. To meet these statutory deadlines, the local Danville approval process will need to be completed by 2023.

### **Regional Housing Needs Assessment**

The foundation for the Housing Element is the RHNA, in which the State estimates each region's housing needs for all income groups every five to eight years. For the upcoming planning period, the State has determined that the Bay Area must plan for an additional 441,176 new housing units. In February 2021, ABAG released their draft RHNA allocation to all the cities and counties in the Bay Area, including the Town of Danville, for the 2023-2031 Housing Element planning period. The Town's draft RHNA for the 2023-2031 planning period is 2,241 units, allocated to specific income groups as shown in Table 1.

### **Housing Opportunity Sites**

The Housing Element must demonstrate the Town's ability to accommodate the RHNA either through production or the availability of properly zoned land that can accommodate additional growth. If adequate sites cannot be identified within the existing zoning, the Town is required to rezone sites that can accommodate the remaining need at a minimum density of 30 dwelling units per acre (for the low and very low income units), which is the default density set by HCD. The Town is not required to build dwelling units in order to meet its RHNA allocation, only to identify potential sites and create the framework to allow the market the opportunity to develop these units.

The Housing Element will explore opportunities to accommodate the RHNA through current production, entitled units, or the availability of properly zoned land that can accommodate additional growth. The Housing Element will further identify and address potential and actual governmental and nongovernmental constraints on the development of housing for all income levels.

### Required Approvals

Actions to be taken by the Town include:

- Certification of the Program EIR
- Adoption of General Plan amendments and Rezonings to update the Housing Element

Following adoption, the updated Housing Element will be submitted to HCD for certification.


### Potential Environmental Impacts of the Project



Mitigation measures will be identified for significant impacts, as warranted. The EIR will discuss the project's significant environmental impacts on the following specific environmental categories:

- Air Quality
- Biological Resources
- Cultural Resources
- Energy
- Geology and Soils
- Greenhouse Gas Emissions
- Hazards and Hazardous Materials
- Hydrology and Water Quality

- Land Use and Planning
- Mineral Resources
- Noise
- Population and Housing
- Public Services
- Recreation
- Transportation
- Tribal Cultural Resources
- Utilities and Service System
- Wildfire

The Program EIR will also evaluate the potential for the project to cause direct and indirect growth-inducing impacts, as well as cumulative impacts. Alternatives to the proposed project will be evaluated that may reduce impacts that are determined to be significant in the Program EIR. Mitigation may be proposed for those impacts that are determined to be significant. A
