CORONAVIRUS DISEASE (COVID-19) ADVISORY AND MEETING PROCEDURE

On March 16, 2020, the Health Officer of Contra Costa County issued an Order through April 7, 2020 that directed that all individuals living in the county to shelter at their place of residence except that they may leave to provide or receive certain essential services or engage in certain essential activities and work for essential businesses and governmental services.

The seven Bay Area Public Health Officers who ordered a shelter in place in mid-March will extend the orders through May 31. This new Order replaces the shelter order issued on March 31, 2020. The March 31 order is the "Prior Order" and the April 29 Order as the "new Order" or "Order." This new Order will go into effect on 11:59 pm on Sunday May 3, 2020, and will remain in effect until 11:59 pm on Sunday May 31, 2020, unless the Health Officer amends or extends it.

Under the Governor's Executive Order N-29-20, this meeting may utilize teleconferencing, as a precaution to protect the health and safety of staff, officials, and the general public. SWAT members will not be physically in attendance, but will be available via video conference.

There will be no physical location for members of the public to participate in the meeting. We encourage members of the public to shelter in place and access the meeting online using the web-video communication application, Zoom. Zoom participants will have the opportunity to speak during the Public Comment period (for topics not on the agenda), in addition to each of the agendized items.

SWAT approved the 511 Contra Costa TDM FY 2020-21 SWAT Programs and Budget, totaling \$490,599.

6.B Discussion – Measure J Safe Transportation for Children Funding Category (SWAT) Lamorinda School Bus Program and TRAFFIX

Lisa Bobadilla, SWAT Administrator introduced this item. Ms. Bobadilla provided SWAT members with information regarding the TRAFFIX program. Amy Worth, Vice Mayor City of Orinda, provided information regarding the Lamorinda School Bus Program.

Both programs have been impacted by the decrease in Measure J revenues for FY 2020-21; therefore, the Contra Costa Transportation Authority has approved a sixmonth budget for the School Bus Programs, effective July 1, 2020 to December 31, 2020.

Due to the decrease in Measure J revenue, virtual learning, and limited funding in their reserve account, the Lamorinda School Bus Program has discontinued service for FY 2020-21.

The TRAFFIX Program, has agreed to a six-month budget to maintain school bus operations and the ability to implement service if and when school resumes in person.

6.C Update – SWAT Records Retention

Lisa Bobadilla, SWAT Administrator presented this item. Ms. Bobadilla stated that since SWAT is a Regional Transportation Committee of the Contra Costa Transportation Authority (CCTA), the records retention policy for CCTA is used for SWAT records.

The City of San Ramon has received several boxes of SWAT historical files dating back to 1997. As the SWAT Administrator, staff has reviewed the boxes and files,

created a spreadsheet for each box listing all files and correspondence, and has forwarded the info to CCTA for review by legal counsel.





EXTENDED REVIEW AND COMMENT PERIOD FOR INITIAL STUDY/DRAFT MITIGATED NEGATIVE DECLARATION

The public review and comment period for the South Camino Pablo Annexation Project Initial Study/Draft Mitigated Negative Declaration has been extended to September 15, 2020. The Planning Commission will receive public comment on the proposed project and the Initial Study on September 8, 2020.

Project Title: South Camino Pablo Annexation Project (aka Camino Pablo Estates)

Project Location: Assessor's Parcel Number (APN) 258-290-023 fronting the east side of Camino Pablo north of Knoll Drive and South of Sanders Ranch Road in the Town of Moraga. The site is located in unincorporated Contra Costa County, but is within the Urban Limit Line and Sphere of Influence for the Town of Moraga.

County: Contra Costa County

PROJECT DESCRIPTION:

The proposed project would develop 13 single-family two-story detached homes on individual lots ranging in size from 15,105 square feet to 40,027 square feet, with an average lot size of approximately 22,367 square feet. Six of the homes would include an accessory dwelling unit (ADU). The homes would be located at the southern end of the site on approximately 8.5 acres, and the remaining approximately 15.4 acres of the site would be preserved as permanent open space. The homes would be accessed from a new public street (Street "A") that would intersect with Camino Pablo, opposite Tharp Drive, creating a new four-way intersection. The new street would terminate at a cul-de-sac and would have a sidewalk on the northeast side of the street. The project would require a General Plan Amendment to change the designation of approximately six acres from Residential, 1 Dwelling Unit per Acre (1-DUA) to Residential, 3 Dwelling Units Per Acre (3-DUA). The 8.5-acre development area, including eleven 3-DUA lots and two Open Space (OS) lots, would have a gross density of 1.53 dwelling units per acre. The project would require annexation into the Town of Moraga.

The original review/comment period for the Initial Study/Draft Negative Declaration began on Monday June 29, 2020 and was scheduled to end on August 24, 2020. The proposed Master Plan is anticipated to be developed over 27



years and include up to 4,500 multi-family dwelling units, a 169-key hotel, 166,000 square feet of commercial space, three new parking structures, and publicly-accessible, privately owned and maintained park and public spaces. Fifteen percent of the 4,500 units (approximately 675) would be affordable units to low and very low income households.

- A Preliminary and Final Development Plan to allow the construction of the Tassajara Parks Project with associated roadway, infrastructure improvements, habitat improvements, and grading activities of approximately 300,000 cubic yards for site preparation and mitigation of landslide hazards.
- A Tree Permit to allow the removal of up to 19 code-protected trees.
- Exceptions from the following provisions of Title-9 (Subdivisions).
 - frontage Improvements and pavement widening
 - streetlights within one mile of an existing school
 - frontage improvements on the side or sides of the roadway adjacent to the subdivision

PROJECT LOCATION: The Tassajara Parks Project consists of approximately 771 acres of land within the Tassajara Valley area of unincorporated Contra Costa County. The site is comprised of four separate parcels that are located along a stretch of Camino Tassajara, just east of the City of San Ramon and Town of Danville limits.

The project site is divided up into two areas, one of which is an approximately 155-acre area called the Northern Site. This portion of the site consists of one parcel identified as Assessor's Parcel Number 220-100-023. Located less than 0.5 miles to the south is the Southern site, which is comprised of three parcels and approximately 616 acres.

The 10-acre Tassajara Hills Elementary School parcel is located immediately west of the Northern Site and will also be impacted as part of the project. Parking lot improvements unrelated to the residential element of the project are proposed to ease traffic circulation on the project site. These are ancillary improvements as they are not required to execute the proposed residential project, and thus the 10-acre school site is not included as part of the 771-acre project area listed above.

ENVIRONMENTAL IMPACTS: The FEIR identifies potentially significant environmental impacts in the following topic areas: 1) Air Quality/Greenhouse Gases; 2) Biological Resources;

3) Cultural Resources; 4) Geology and Soils; 5) Hazardous Materials; 6) Hydrology and Water Quality; 7) Noise; 8) Transportation and Traffic; and 9) Utilities and Service Systems. Most potentially significant impacts of the project can be mitigated to less-than-significant levels. However, significant, and unavoidable impacts have been identified in the Air Quality/Greenhouse Gases and Transportation and Traffic topic areas.
