6.A **Presentation** – County Connection Proposed Fare and Service Restructure

Ruby Horta, Planning Director, County Connection presented the item. The proposal is a draft. At this time, it includes eliminating non-productive routes and/or adding service to routes with high demand. Within SWAT region, the routes proposed to be eliminated or enhanced include:

*Route 6* – Lafayette/Moraga/Orinda – increase frequency every 20-30 min peak/40-120 minutes off peak;

Route 25 – Lafayette BART/Walnut Creek BART – eliminate due to low ridership;

*Route 35* – San Ramon Transit Center/Dublin BART – adding Crow Canyon Rd to the route, increase frequency every 20 min peak/40-60 minutes off peak, increase service in the Dougherty Valley/Windemere corridor;

*Route 36* – San Ramon Transit Center /Dublin BART – eliminate due to low ridership;

There will be no changes to the 600 series routes which are school routes.

County Connection is also proposing a fare restructure. The last fare restructure was in 2009.

#### **SUMMARY**

Staff hereby presents this informational to the SWAT Board, consistent with Lamorinda Action Plan review process for Lamorinda General Plan Amendments (GPAs) and projects whose trip generation estimates exceed 100 peak hour trips.

#### **BACKGROUND AND ANALYSIS**

In September 2018, the Town of Moraga issued the Revised Final Environmental Impact Report (FEIR) for the Bollinger Valley Project. The proposed Project consists of 126 single-family residences, along with six alternatives of various development scales, near the City of Lafayette boundary.

The FEIR is an update to the prior 2013 Draft Environmental Impact Report (DEIR). Shortly after DEIR publication five years ago, the Lamorinda Program Management Committee (LPMC) reviewed and submitted a letter response to Town of Moraga, emphasizing concerns about potential Project-related impacts on the sub-regional transportation system. Today, the LPMC reconvened to consider a subsequent letter response to the FEIR currently under review by Town of Moraga.

For the SWAT Board's reference, the draft LPMC response letter to the FEIR is attached to this staff report; any modifications suggested by the LPMC Board

will be conveyed verbally for the time-being, and later incorporated in a final letter for transmittal.

To-date, the Town Planning Commission has held multiple public hearings on the FEIR. The Town Council is next scheduled to hold a public hearing on November 14, 2018. The full FEIR document is available on the Town of Moraga's website, at the following link:

#### INTRODUCTION & BACKGROUND

The Lamorinda Action Plan stipulates that the LPMC Board be informed of proposed projects and General Plan Amendments (GPAs) anticipated to generate 100 or more peak hour trips. This report is intended to satisfy that policy, as it relates to the proposed Bollinger Valley development project in Town of Moraga.

In 2013, the LPMC Board transmitted a letter response to Town of Moraga regarding the Draft Environmental Impact Report (DEIR) for the Bollinger Valley development project (Project). The Board's letter primarily entailed concerns regarding "significant and unavoidable" sub-regional transportation impacts, as well as various mitigation measures requiring additional funding and implementation beyond Town boundaries. More recently, in September 2018, the Town issued the Project Revised Final Environmental Impact Report (FEIR). The Project proposes 126 single-family residences, along with six alternatives of various development scales, near the City of Lafayette boundary.

In mid-October, the Town Planning Commission held multiple public hearings on the FEIR. The Town Council is next scheduled to hold a public hearing on November 14, 2018. The full FEIR document is available on the Town of Moraga's website, at the following link: http://www.ci.moraga.ca.us/dept/planning/Major%20Projects/BollingerValley

#### ANALYSIS

The current FEIR is an update to the 2013 DEIR, featuring an additional, sixth development alternative of 85 single-family residences. The FEIR also reflects some updates to the environmental analysis in response to numerous public comments on the DEIR from locally and regionally-based residents and agencies, respectively, and includes more recent underlying cumulative development and traffic growth assumptions. Generally, however,

the vast majority of transportation-related environmental impacts, including those that are "significant and unavoidable", remain likely under the proposed Project.

Staff has prepared a draft letter response to the FEIR, for consideration by the LPMC Board. This letter is attached to the staff report. Considering the relative consistency and continuous documentation of potential sub-regional transportation impacts between the DEIR and the current FEIR, the tenor and content of the newly-drafted letter largely mimics the Board's previous response to the 2013 DEIR. Staff recommends that the Board review the current draft letter and suggest modifications, as it considers appropriate.

Thank you for the opportunity to comment on the Revised Final Environmental Impact Report (FEIR) prepared for the Bollinger Valley Project in the Town of Moraga. The Lamorinda Program Management Committee (LPMC) met on November 5, 2018 to review and comment on the FEIR. LPMC is a subcommittee of the Contra Costa Transportation Authority's Southwest Area Regional Transportation Planning Committee (SWAT). LPMC provides a forum for discussion for Lamorinda cross-jurisdictional transportation issues. All three member jurisdictions' representatives were present at the meeting. LPMC members Don Tatzin (Lafayette) and Amy Worth (Orinda) voted in favor of sending a comment letter on with LPMC member Dave Trotter (Moraga) abstaining. LPMC agreed to submit the following comments:

- The LPMC believes the conclusions of the FEIR that the project and several of its alternatives would have significant and unavoidable transportation impacts are true. Some of the mitigations offered for significant impacts that the EIR states could be reduced to less than significant may not be feasible to implement in the adjoining jurisdictions.
- Significant Project-related impacts have been identified on two Routes of Regional Significance, as defined in the Lamorinda Aciton Plan, including SR-24 and Pleasant Hill Road. This would potentially result in an increase to the Multimodal Transportation Service Objective (MTSO) for delay index along those routes. LPMC expresses concern that this renders the Project inconsistent with the Action Plan and may jeopardize Moraga's ability to receive Measure J Return-to-Source funds for future capital improvements on the transportation network. LPMC further suggests the EIR or the Town's own review of the project should include an analysis of the immediate and future financial impact to the Town of violating the Action Plan.
- The FEIR states that if insufficient funds are available, the applicant "shall fully fund and construct the mitigation measure, and shall be reimbursed for the portion that is beyond their fair share contribution from future available funding sources." As was

true for the 2013 DEIR, it remains unclear where these future funding sources will come from. Therefore, LPMC requests specifying which funding sources are to be used.

- Even if the Lamorinda Fee and Finance Authority's list of projects is updated to include proposed mitigations, the local jurisdictions may have higher priority for funding other projects also included on the expenditure list. There is no near-term guarantee that LFFA funds would be available and it is a local jurisdiction's decision on project funding priority.
- The FEIR includes the amount of time delay for a number of intersections, including those in neighboring jurisdiction of Lafayette and Orinda. Unfortunately this does not give a sense of what the total delay might be for a traveler on a route when going on a typical trip from Point A to Point B. While not required of a FEIR, the LPMC suggests developing several route analyses so members of the community can have a more complete understanding of the delay impacts for the project and its alternatives. Several typical routes such as from Sanders Ranch in Moraga, Burton Valley in Lafayette, and Southern Orinda to Bishop Ranch in San Ramon, to the Lafayette or Orinda BART stations, and to Oakland or points further west could be calculated by summing up the delay for each intersection studied along the route and also considering the impact, if any, of the project on travel speeds between intersections. This analysis would show the time differences to travel these routes with and without the project or its alternatives. This information could help members of the public and decision makers better understand how the various proposals might impact a typical resident of the area.

**Subject**: *Requesting SWAT's support of Contra Costa County's application to the Caltrans Sustainable Communities Grant program* 

#### Introduction

The Caltrans Sustainable Communities Planning Grant Program provides funding to support regional sustainable communities strategies intended to achieve the State's greenhouse gas reductions targets. This cycle includes approximately \$25 million in Senate Bill ("SB") 1 statewide competitive funding. Recipients tend to receive between \$200,000 and \$400,000, and an 11.47% match is required. Applications are due November 30, 2018. To date, the Transportation, Water & Infrastructure Committee has authorized the Department of Conservation and Development (DCD) and Department of Public Works (PWD) to pursue this grant, and DCD has received a letter of support from Bike East Bay and Diablo Street Smarts.

#### **Proposed study**

DCD and PWD propose the "Expedited Active Transportation Infrastructure Plan;" a study that will inventory the County's roadway network and identify opportunities to quickly re-stripe or repave streets to include new or enhanced bikeways and sidewalks. The Plan will develop a project list ranked by location in disadvantaged unincorporated communities, ease of implementation, and overlap with the County's travel demand model, as well as a web map to track project status. Staff will hold one round of outreach to ask for feedback on the plan's prioritization methodology, and they will conduct ongoing outreach and evaluation as projects are built. Staff will use the grant award to hire a consultant to carry out the technical tasks of the study. The roadway inventory data to be gathered for this Plan can also be leveraged to support concurrent planning efforts such as the RTPC action plans, the County's 2018 Bicycle and Pedestrian Plan update, Vision Zero, and Complete Streets upgrades triggered by new development in unincorporated areas.

The Southwest Area Transportation Committee ("SWAT") met Monday, October 1, 2018. The following is a summary of the meeting and action items:

#### Dear Ms. Saltzman:

I am a resident of Moraga. I believe strongly in public transportation and enthusiastically supported the Measure J sales tax and other Bond Measures over the years which aim to support BART and the Contra Costa County Transportation Authority. However, I am extremely disheartened by the recent changes at the Lafayette BART station. My Moraga neighbors and I were so hopeful after so many years of not being able to park at the station that the recent improvements there would include a significant increase in the number of parking spaces available. We were so looking forward to being able to easily use BART during the week to go to San Francisco for our cultural and social life and to get to the airports. When we learned that the Lafayette Town Council and wealthy neighbors living near the Lafayette BART Station successfully used what we viewed as spurious concerns about congestion on Happy Valley Road and in downtown Lafayette and concerns about "blocked views" to persuade the decision makers not to expand parking at all, my neighbors and I suffered a severe case of "taxation without representation". Given the many decades it has taken to make even the current modest environmental upgrades to the Lafayette BART Station we are legitimately concerned that we can not expect any further changes to occur within our remaining lifetimes that would make Lafayette BART accessible for us.

As you may be aware, for many years now, Moraga residents who do not arrive at the Lafayette BART station by 7:20 am on weekdays are usually not guaranteed finding a place and are unable to park cheaply all day anywhere nearby. Given the low frequency of County Connection Bus Service on Line 6 - every two hours during mid-morning to mid-afternoon and every forty minutes at other times, the County Connection rarely meets our needs. In addition, there is no service to Moraga from Lafayette or from Orinda after 7:00 pm and 8:00 pm respectively, so using BART to meet friends for dinner, or to go a show requires us to use a taxi to go to and from BART which is expensive. Given the unreliability of those few buses that do serve Moraga, we must also use a taxi if we have doctor's appointments in the City during the week, or - now that we are retired - want to use BART on a specific schedule in order to meet friends for timed entrance to one of the special museum exhibitions or to make it on time for lunch reservations. In short, the current state of affairs completely disregards the needs of Moraga taxpayers and residents.

Having lived in Japan and having spent significant time in other countries such as Switzerland and Denmark all of which have excellent public transportation - I know that we can do much better. One suggestion would be to make improvements to parking at the Orinda BART station a fast-track priority. Given the Orinda BART stations location next to the freeway, creating a another tier on top of the existing parking lots would create access for Moraga residents even though it is three miles farther to Orinda BART than to Lafayette for us. We would definitely drive to Orinda BART during the week if we knew we could find parking there.

A second less helpful solution would be to replace the existing County Connection buses with small vans operating every ten minutes from early morning to late at night such as those used at airports to transport passengers from the terminal buildings to outer parking lots. These vans typically have two level platforms behind the driver for luggage, disabled and elderly passenger seating opposite the luggage platforms, and front facing seats in the remaining sections of the van. Their smaller size and frequent schedule would permit Moraga residents to rely on them - especially if all Moraga bus stops were equipped with illuminated information signs which indicated how many minutes remained before the arrival of the next van.

This correspondence reports on the actions and discussions during the TRANSPLAN Committee meeting on October 11, 2018.

#### **CONSIDER:**

- 1) An exception to Policy 8 in the 2016 Measure J Strategic Plan to allow the programming of eBART Measure J savings to the Antioch BART Station Parking Lot Expansion; and
- 2) An amendment the 2016 Measure J Strategic Plan to program \$1.82 million funds from the East County "BART Parking, Access and Other Improvements" category to the Antioch BART Station Parking Lot Expansion, as recommended by the TRANSPLAN TAC.

BART Director Joel Keller and staff Maurice Rattray delivered a presentation to the Committee detailing the proposed project and funding plan. Committee members recommend TRANSPLAN, CCTA and BART immediately begin planning future improvements (e.g. satellite lots with shuttles, enhanced local bus service, real-time parking information on the road and via app, etc.) as it is likely the proposed project will provide only temporary parking relief. Ultimately, the Committee approved a motion to support the project and concur with the 2016 Measure J Strategic plan Policy 8 exception and program funding amendment requests as proposed.
